2.SCOPE OF WORK:-

1. Replacement of 80/125W HPMV FLP well glass Light fixtures with LEDs

Most of the plant lighting of HOCL, Ambalamugal is 80/125W HPMV FLP well glass Light fixtures. Vendor shall replace these FLP well glass light fixtures with 45W FLP LED well glass Light fixtures. The scope includes cable disconnection from existing lighting fixture, dismantling the old HPMV well glass Light fixtures, Installing the new LED well glass Light fixture in place of the old one including cable glanding and termination. The new LED FLP well glass light fixtures, FLP DC cable glands and hard wares shall be supplied by HOCL free of cost. Most of the light fixtures can be accessed via 12 feet step ladder.
