General instructions for Online Bid Submission

The bidders are required to submit soft copies of their bids electronically on the Central Public Procurement Portal(Govt. Of India), using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at: https://eprocure.gov.in/eprocure/app.

REGISTRATION

- Bidders are required to enrol on the e-Procurement module of the Central Public Procurement Portal (URL: https://eprocure.gov.in/eprocure/app) by clicking on the link "Online bidder Enrolment" on the CPP Portal which is free of charge.
- As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- 5. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6. Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

SEARCHING FOR TENDER DOCUMENTS

SCOPE OF WORK

General Scope of Work for Maintenance of Heat Exchanger E 4507 (FAC Overhead Condenser) and E 3002 (Evaporator Pre-Flash Condenser) include but not limited to the following:

- 1. Once the equipment is ready for maintenance after the issue of safety permit, isolation of equipment by putting blinds/ spectacle blinds in feed (inlet) and out let nozzles and all other nozzles indicated/instructed for the purpose and fix blind number tags.
- 2. Record the blind tag Nos. in the blind register and obtain signature in the register by Engineer-in-Charge.
- 3. Assisting the inspecting team engaged in the inspection of Heat Exchanger.
- 4. CRANE / DERRICK required for the successful completion of the entire work shall be arranged by the contractors at his own cost.
- 5. Supply of Scaffolding material (pipe and clamps) and erection of scaffolding if required shall be arranged by the contractor.

The Detailed Scope of Work Includes but Not Confined to the Following:

- 1. Blinding of all nozzles including inlet and outlet lines, temperature indicators, and pressure gauge nozzles of the equipment. Providing end blinds on all the piping flanges. Utmost care should be taken while blinding the flare system, in order to avoid any disturbance in flare system
- 2. Removal of nuts of foundation bolt after removing the grouting.
- 3. DROPPING OF THE HEAT EXCHANGER (INCLUDING SHELL) TO GROUND LEVEL WITH CRANE/ DERRICK WITHOUT DAMAGING THE FOUNDATION OR EXCHANGER. THE EXCHANGERS, E 4507 IS ABOUT 15MT AT AN ELEVATION OF ABOUT 10 MTRS AND E 3002 IS ABOUT 13MT AND AT AN ELEVATION OF ABOUT 20 MTRS. SUITABLE CRANE/DERRICK SHALL BE ARRANGED BY THE CONTRACTOR.
- 4. Transport the exchanger to suitable location, secure the exchanger to a proper place and pull the tube bundles. Cleaning of all nozzles and flange faces
- 5. Cleaning of the tube bundle/shell will be arranged by HOC through other agency.
- 6. Re-assembly of Heat Exchanger and hydro testing of the same as per the scope of work.
- 7. RE-ERECTION OF THE HEAT EXCHANGER ASSEMBLY WITHOUT DAMAGING THE EXCHANGER AND FOUNDATION AFTER CLEANING THE FOUNDATION BOLTS AND NUTS.
- 8. Normalizing pipe lines of the Exchanger by putting new gaskets without disturbing the flare system as per the instruction of Engineer-in-Charge.
- 9. Necessary scaffolding has to be provided wherever required by the contractor at his cost.
- 10. HOC will be providing only the necessary gaskets nuts and bolts. All other items required for the job has to be brought by the contractor.
- 11. Test certificate of the crane and lifting tools and tackles has to be provided before commencement of work.

GENERAL PROCEEDURE FOR FLOATING HEAT EXCHANGERS

- 1. Once the equipment is ready for maintenance after the issue of safety permit, Isolation of equipment by putting blinds/spectacle blinds in feed and out let nozzles and all other nozzles indicated for the purpose and fix blind number tags as per the instruction of Engineer in charge.
- 2. Open and remove channel head cover
- 3. Open and remove channel head
- 4. Open and remove shell cover and floating head cover.
- 5. Pull out the tube bundle and bringing it to ground as per the instruction of Engineer-in-Charge.
- 6. Clean the tubes and shell, channel head cover, channel head shell, floating head, floating head cover and dish end cover using hydro blasting machine (Karcher Pump) available in HOCL and all flange serration by scrappers / wire brushes. If Hydroblasting is required for cleaning, the same will be arranged by HOCL at their cost.
- 7. Blinding shell side and tube side in the required sequence and stages, suitable for hydrotest of tube side and shell side separately.
- 8. Assemble the tube bundle, channel head shell, channel head cover, floating head, floating head cover and dish end cover in required sequence and stages suitable for Hydrotest of tube side and shell side separately.
- Hydrotest the exchanger on shell side and tube side and floating head gasket, dish end cover gasket.
- 10. Leaking tubes if any noticed during hydrotest should be plugged using CS/SS/Brass plugs as per the instruction of Engineer-in-charge. Required plugs will be supplied by HOC at free of cost. Repeat the hydrotest if any leak at shell side / tube side.
- 11. You shall get the hydrotest witnessed by Engineer # in-charge / 3rd party Inspector.
- 12. Test rings should be used for testing floating head type exchangers tube bundle. (Test rings are available in main store yard / maintenance workshop, the same has to be identified, cleaned, transported to the heat exchanger. After testing, the test rings are to be transported back to the original location).
- 13. Test pressure for hydrotesting should be as per the instruction of the Inspector/Engineer-in-charge.
- 14. Removal of isolations (ie. blind, spectacle blinds, blind tags etc.) for normalizing the Heat Exchanger.
- 15. Hot bolting of the flanges after putting the equipment in line if it is required. However, this activity will not be counted for the completion time for the work.
- 16. In case of cleaning of tubes by hydroblasting (by HOCL through other agencies), there will be a gap of 1 or 2days (for cleaning) in between opening / boxing up of exchanger. However, this activity will not be counted for the completion of the work.

Note:

Clause No. X: 50% of the quoted rate only will be paid to the party if the tube bundle is not pulled out and brought to the ground (ie. only hydro testing of the tube side and shell side and plugging of the leaking tube is done.)

Clause No. Y: 50% of the quoted rate only will be paid to the party if HOCL provide crane for the entire work.

TESTING AND INSPECTION

SPECIAL CONDITIONS OF CONTRACT

HOCL is planning to take 30 days shutdown in 2024. Since the external environment is favourable to HOCL, all works has to be completed within the stipulated period for early startup of plant. The contractor has to put people as 12 hrs. shift basis (2 shifts – 8.00AM – 8.00PM, 8.00PM – 8.00AM) in full strength. Contractor has to take care the same while submitting their offer. Any deviation will be viewed very seriously. Also please note that the completion period spelt in NIT is for each work. (Hence, the LD Clause will be applicable to each work also.)

- 1. Contractor has to ensure that one electrician and one safety officer should be available in both the shifts in each site.
- 2. Contractor has to ensure that there should not be any delay in shift change overtime. The work has continue in same momentum during shift change time (8.00AM & 8.00PM). Measures to be made by the contractor to bring workers in advance for the same.
- 3. All manpower, tools, tackles, hydraulic test pumps, lifting tools, ropes, wire brushes, chain pulley block, wheel barrows etc. whatever required for the work are to be arranged by the contractor. A list of tools and tackles intended to be brought for the work by the contractor has to be kept along with the bid.
- 4. Spiral wound Gaskets, bolts, nuts, fasteners required for the work will be supplied by HOCL free of cost as per requirement. But HOC will issue only the gasket sheets for initial blinding. It has to be cut to the correct size by the contractor at his cost.
- 5. Safety Helmets, safety shoes, goggles, safety belts and other PPEs etc. for the workmen and supervisor employed for the work are to be arranged by the contractor.
- 6. No work to be carried out without wearing safety gadgets (PPE's), work order, confined space entry record and safety work permit by the employees of the contractor.
- 7. This work is a shutdown activity and you have to put all efforts to complete the work in time. Also you have to deploy people on round the clock basis as per the instruction of Engineer-in-Charge.
- 8. The entire work is to be carried out as per the standard engineering practice and subjected to stage inspection by HOC/3rd party inspection agency.
- 9. All debris, waste etc. arising out of the job should be segregated weighed, transported and dumped into the scrap yard as per the instruction of Engineer-in-Charge at your cost. The contractor also has to abide by the guidelines for Environmental Protection.
- 10. HOC has every right to stop the work if the progress and quality of work is found unsatisfactory. The balance work will be carried out by HOC through another agency at the cost and risk of the first contractor.
- 11. Contractor has to mobilise the complete team with necessary tools and tackles within 24 hours from the time of intimation to start the work.
- 12. Either the contractor or his authorised supervisor shall be available at work site throughout the work in both shifts.



- 13. Being a shutdown job, the quantity shown can vary ie. Increase or decrease depending upon the situation. However, the rate and other terms and conditions shall be same throughout the pendency of the contract for which the contractor shall be ready.
- 14. Appropriate insurance shall be arranged by the contractor for the coverage of the liability to the people employed by them, arising out of any accident occurring during the execution of the work.
- 15. The Contractor shall follow all clauses in Annexures ESI, Safety Regulations and General Conditions of Contract, Workmen Compensation, Personal Protective Equipments (PPE), Labour Laws, PF, Guidelines to contractors/suppliers for environmental protection & Confined Space Entry, Scaffolding Checklist, Scaffolding Manual & Scaffolding Parts & Erection Procedure (Tube & Clamp).
- 16. Contractor shall get prior permission from the Engineer-in-Charge for bringing the material to HOC.
- 17. Contractor shall ensure that a standby person is kept outside the man-way nozzle when the work is inside a confined space.
- 18. You are requested to visit the site to ascertain the exact quantum of work/site condition and get acquainted before submitting your offer.
