### **SCOPE OF WORK**

## THIS DOCUMENT TO BE SIGNED AND SEALED BY BIDDER ON ALL PAGES AND SUBMITTED ALONG WITH THE E-TENDER

Contractor shall carry out the Installation, Testing and Commissioning of LED street light fixtures, LED flood light fixtures and Junction boxes as per the scope of work given below.

### a) Installation of 60W LED light fixture:

Contractor shall install and commission the 60W LED street Light fixture as per drawing No. ELE/H2O2-UTY/01. All the structural items such as 40mm NB G.I pipes (class B, TATA/JINDAL make), M.S flat, M.S Angles, Bolt, Nut and washers shall be supplied and erected by the contractor. Support pipe shall be bended to approximately 105 Degree angles as per the drawing. All the structural items after fabrication and welding shall be painted using one coat epoxy primer and one coat epoxy finish paint of light/smoke grey colour. Dimension of clamp given in the drawing are approximate only. Contractor shall take the actual measurement required for pipe clamps from site before starting the fabrication works. Scaffold platform required for the installation work shall be arranged by contractor. All the welding and fabrication works are under scope of contractor.

### b) Installation of 36/40/45W LED light fixture:

Contractor shall install and commission 36/40/45 LED street Light fixture as per drawing No.ELE/H2O2-UTY/02. All the structural items such as 25 mm NB G I pipes (Class B, TATA/JINDAL make.), M.S flat, M.S Angles, Bolt, Nut and washers shall be supplied and erected by the contractor. Support pipe shall be bended to approximately 105 Degree angles as per the drawing. All the structural items after fabrication and welding shall be painted using one coat epoxy primer and one coat epoxy finish paint of light/smoke grey colour. Dimension of clamp given in the

drawing are approximate only. Contractor shall take the actual measurement required for pipe clamps from site before starting the fabrication works. Scaffold platform required for the installation work shall be arranged by contractor.

### c)Installation of 100W LED flood light fixture:

Contractor shall install and commission 100W, IP65 non-flameproof LED flood light fixture on Building parapet wall (at a height of nearly 8 meters from FFL and on existing lighting poles (75 mm G.I pipe having height nearly 7 to 8 meters from FFL) as per drawing no ELE/H2O2-UTY/04. Existing light fixture 250W HPMV from parapet wall and existing light poles shall be removed by contractor wherever we are replacing it with 100W LED flood light fixtures. All the required M.S structural, Anchor fastners, Bolts and Nuts shall be supplied by party. M.S structural shall be painted using one coat Epoxy primer and one coat epoxy paint of smoke grey colour. All welding work and fabrication work shall be done by party. Scaffold platform for installing flood light fixtures on existing light poles shall be arranged by party.

### d)Installation of Street Light Junction Boxes:

Contractor shall dismantle the existing damaged lighting junction boxes (Sintex make) installed at base of concrete light poles and replace it with new junction boxes supplied by HOCL. Cable gland dismantling, termination, installation and commissioning works shall be done by party. Old cable glands shall be removed and new cable glands shall be installed. Excavation and vegetation cutting around concrete light poles incase required for cable glanding shall be done by party. All the cable glands are of single compression type of good quality. Junction boxes supplied by HOCL shall have suitable Elmex connectors and HRC fuses. Contractor shall provide necessary holes on the JBs depending up on site situations. All the JBs are of Sintex make. In normal conditions street light Junction boxes shall have 2 nos 3Cx25 sq.mm AYFY cable and 1 no.3Cx2.5 sq.mm YWY cable terminated on it. Cables going to street light fixtures shall be properly clamped on the concrete light poles at suitable intervals. Clamping arrangement shall be permanent type either by suitable size aluminum strips or clamps. All the screws used for JB installation and clamping shall be stainless steel type.

### **General instructions for Online Bid Submission**

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at: https://eprocure.gov.in/eprocure/app.

### **REGISTRATION**

- Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: https://eprocure.gov.in/eprocure/app) by clicking on the link "Online bidder Enrollment" on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

### SEARCHING FOR TENDER DOCUMENTS

- 1) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.
- 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

### PREPARATION OF BIDS

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or "Other Important Documents" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

**Note:** My Documents space is only a repository given to the Bidders to ease the uploading process. If Bidder has uploaded his Documents in My Documents space, this does not automatically ensure these Documents being part of Technical Bid.

### **SUBMISSION OF BIDS**

- Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 3) Bidder has to select the payment option as "offline" to pay the tender fee / EMD as applicable and enter details of the instrument.
- 4) Bidder should prepare the EMD as per the instructions specified in the tender document. The original should be posted/couriered/given in person to the concerned official, latest by the last date of bid submission or as specified in the tender documents. The details of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected.
- 5) Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BoQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BoQ file, open it and complete the white coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.
- 6) The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- 7) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a

system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid opener's public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.

- 8) The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 9) Upon the successful and timely submission of bids (i.e. after Clicking "Freeze Bid Submission" in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no and the date & time of submission of the bid with all other relevant details.
- 10) The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.










# FRONT VIEW OF GI PIPE INSTALLATION




# TOP VIEW OF SINTEX JUNCTION BOX INSTALLATION
